1. PHOTO ID and SOCIAL SECURITY IDENTIFICATION are REQUIRED.

This means that you bring either your SOCIAL SECURITY CARD or your SOCIAL SECURITY BENEFIT STATEMENT for you and (if you have one) your spouse.

- 2. Bring social security cards for anyone else on the tax return kids, grandkids, anyone who you provide support for, dependents.
- 3. Bring your social security benefit statement if you and/or your spouse receive social security. It shows the dollar amount received last year. If you received a lump sum distribution this year from social security for prior years, bring tax returns from those year(s). They will be required to determine the taxable part of social security!
- 4. <u>Banking information will speed up your refund by six weeks!</u> <u>Bring a check (not a deposit ticket) to show your bank routing and account information.</u> <u>THIS IS NEW THIS YEAR DUE TO IRS CHANGES!</u>
- 5. Bring last year's 2024 tax return. The 2023 tax return might also be helpful.
- 6. Fill out the attached / enclosed "Intake and Interview" form. Please fill this form in BEFORE you come to the site. Filling it in at the site will make the process longer for you. We do federal and Kentucky returns. No other state returns
- 7. Bring all your tax documents and any paperwork that affects your tax return.
- 8. Our "front desk" volunteers will briefly review your documents and organize them.
- 9. A Tax Preparer will review your photo id, social security cards and forms, the "Intake and interview" form and all other tax forms to determine if we can do you return.
- 10. If we can do your return, we will prepare your return and a second Tax Preparer will then meet with you to go over the return in detail again. This is what we call a Quality Review.
 - If we cannot do your return, we will tell you why and return all your documents to you.
- 11. Your tax return will be printed and reviewed with you. You will be asked to sign an <u>8879 IRS</u> form that tells the IRS "under penalty of perjury your return is true, correct and complete."
 - This 8879 form also authorizes the site to electronically file your federal and Kentucky state tax return. Your return will be e-filed shortly following your approval and after you sign the 8879 document.
- 12. All of your documents, including your printed tax return, will be returned to you.
- 13. If you are requesting us to prepare a tax return from a prior year such as 2024, 2023 or 2022, there are requirements other than that listed above. One appointment per tax return. Hopefully, you had a conversation with the site manager before coming to the site.

How AARP Foundation Tax-Aide Can Help You Today

We offer free tax return preparation to anyone who needs it. AARP Foundation Tax-Aide volunteers are trained to help you file a variety of income tax forms and schedules.

In certain situations, however, our volunteers may be unable to provide assistance. The Volunteer Protection Act requires that our volunteers stay within the scope of tax law and policies set by the IRS and AARP Foundation. Here's a guide to what our Tax-Aide volunteers can — and can't — do.

We <u>can</u> prepare most returns with:

- Wages, interest, dividends, capital gains/losses, unemployment compensation, pensions and other retirement income, Social Security benefits.
- · Self-employment income, with limits.
- Schedule K-1 that includes only interest, dividends, capital gains/losses, royalties, or foreign taxes (within limits)
- Qualified Business Income deduction.
- New qualified tips, overtime, vehicle loan interest and senior deductions.
- Itemized deductions, including noncash contributions to charity that total no more than \$5,000.
- Cancellation of nonbusiness credit card debt.
- IRA contributions deductible or not.
- Most credits, such as earned income credit, education credits, child/additional child credit and credit for other dependents, child/dependent care credit, premium tax credit, simplified method foreign tax credit and retirement savings credit.
- Estimated tax payments.
- Injured spouse allocation, depending on state.
- Health Savings Accounts (HSA).
- Amendments to filed returns.
- Certain prior year tax returns.

We <u>can't</u> prepare returns with:

- Complicated Schedule K-1.
- Rental income, except land-only rentals or rentals of personal residence less than 15 days.
- Royalty income with expenses if not from self-employment.
- Tax on a Child's Investment and Other Unearned Income (Kiddie Tax).
- Farm income or expenses.
- Some investment income or itemized deductions that are not included in our training.
- Alternative Minimum Tax, Additional Medicare Tax, or Net Investment Income Tax.
- Foreign financial asset reporting requirements.
- Form 1099-DA and certain other digital asset transactions (including virtual currency).
- Solar energy credits.Clean vehicle credits.
